## 52 Installation of a Playground at Llysgwyn / Bryn Glas, Llangyfelach

The Clerk stated that Swansea Council had commenced the work of installing the new play equipment at the playground at Llysgwyn / Bryn Glas. Council discussed the playground and sought suggestions to further improve it with a footpath.

**Resolved** that the Clerk liaise with Swansea Council to establish whether a pathway will be installed from the gate entrance to the play equipment.

Councillor P R Crayford suggested that a video be pre-recorded with Father Christmas and possibly pupils from Llangyfelach Primary School singing. The Chair of Council and Councillor P R Crayford to discuss further and if viable proceed with the suggestions.

### 55 Training

The Clerk stated that he had received the information as requested from Llangyfelach AFC in relation to their request for a grant. The Council considered the matter further and asked for further information.

- To invite a representative from Llangyfelach AFC to attend the Council Meeting on 10 December 2020 to answer any queries that the Council may have.

# 58 Planning Applications & Planning Matters - Swansea Council

i) Application No.: 2020/2177/NMA. Bryn Whilach Farm, Solar Farm, Morriston, Swansea, SA5 7PE

**Resolved** that the Clerk submit an objection in relation to this Planning Application due to the loss of green space, loss of habitat for animals, the significant number of green energy parks already in the area and the fact that there is already a Solar Farm nearby and this additional one could be considered over intensification.

### 59 Highways, Footpaths, Cycleways & Bridleways - Swansea Council

The Clerk outlined the responses received from Swansea Council in relation to:

- i) Parking on pavements on Maes y Dderwen.
- ii) Vehicles speeding on Swansea Road.
- iii) Hatched Area or Bollards Required around the Defibrillator.

#### Resolved that:

- 1) The responses be noted.
- 2) The Chair of Council liaise with Llangyfelach Church to establish the external permitter area owned by the Church outside of the Church Hall.
- 3) Councillors P R Crayford & P Gibson meet on site to consider re-locating the Defibrillator closer to the stepped entrance to the Church Hall.



4) The above mentioned Councillors provide feedback to the Clerk, so that he can liaise with Swansea Council to re-instate the hatched area surrounding the Church Hall and to pursue the possibility of placing a bollard(s) around the Defibrillator; thereby preventing vehicles from blocked access to the Defibrillator.

# 60 Community Budget Capital - Play

The Clerk stated that Swansea Council's Cabinet had provided an additional £1m under the Community Budget Capital Scheme ringfenced specifically to support play schemes and facilities. Councillor D G Sullivan in his role as Llangyfelach Ward Councillor for Swansea Council had expressed an interest in the Scheme and asked Llangyfelach Community Council to consider the matter.

Both playgrounds within the Llangyfelach Community Council area are owned by Swansea Council. They are Llysgwyn / Bryn Glas Playground and Fairview Road Playground.

The Llysgwyn / Bryn Glas Playground has been assessed by Swansea Council as having Amber status; meaning that it needs an upgrade. The Community Council has previously committed approximately £25,000 to this playground and those works are currently underway. The playground will therefore likely rise to Green status.

The Fairview Road Playground has been assessed by Swansea Council as having Red status; meaning that it is desperate for an upgrade and well beyond its life use expectancy. Discussions ensued about the future use of Fairview Road Playground and it was suggested that a BMX / Bike Trail like the one within Morriston Park could be placed at the location.

**Resolved** that Councillor D G Sullivan outline the proposal to Swansea Council to gain support and costings. The Community Council is minded to financially assist be funding an element of the project.

### 61 Llangyfelach Community Gardens - Request for a Grant

The Clerk stated that a request for a grant had been received from Llangyfelach Community Gardens.

#### Resolved that

- 1) The Clerk contact Llangyfelach Community Gardens to request:
  - i) An outline of their agreement with Llangyfelach Church for the use of the land.



- ii) A copy of their latest audited accounts or a statement of accounts so that their financial position can be assessed. Should Llangyfelach Community Gardens not have any accounts or a Bank Account, then the Clerk is authorised to seek other means of safeguarding the Community Council's funds.
- 2) The request for grant to be discussed further when the information requested has been received.
