98 Feedback from Delegates on Outside Bodies

The Clerk stated that Councillors Mike Glover & Adrian Roberts are the Council representatives. Councillor Adrian Roberts stated that he had attended and provided feedback.

99 Workplan (For Information)

100 Swansea Council Matters: Planning, Highways, Footpaths, Cycleways & Bridleways

There were no issues raised.

101 Training Plan

The Clerk stated that the Training Plan was adopted on 13 April 2023. It sets out the training requirements for Community Councillors and Staff. The monthly One Voice Wales, Planning Aid Wales and other relevant training schedules have been circulated. Councillors should regularly review their training requirements in line with the Training Plan & Training Matrix. To attend training, liaise with the Clerk.

The Clerk stated that he would like to undertake the FILCA (Financial Introduction to Local Council Administration) qualification. The qualification is administered by the SLCC (Society for Local Council Clerks) and costs £144.

102 Llangyfelach Ward Councillor Update

Councillor Mark Tribe, Llangyfelach Ward Councillor submitted a verbal report outlining his work within the Ward.

103 Christmas Tree, Illuminations & Festivities

The Clerk stated that the Christmas Event was scheduled for Friday, 1 December 2023. Father Christmas, the Sleigh, St John Ambulance Cymru First Aid Cover & Pontarddulais Brass Band had been booked and a 20ft Nordman Fir Tree purchased. The Clerk stated that he had completed Swansea Council's Event Planning webform.



The Vice-Chair provided feedback from the Christmas Event planning meeting. Councillors discussed the timings and specific details of the event including lighting the path to the Church, Illuminations and tasks for Councillors and Clerk. Councillor Mark Tribe stated that he would match fund the £300 allocated for illuminations, taking the pot to £600.

The Clerk was asked to delay purchasing the 300-350 Selection Boxes until after the next meeting of Council, as the price may reduce after Halloween and Bonfire Night.

Resolved that:

- 1) The update be noted.
- 2) Councillor Sharon Phillips be tasked with identifying appropriate illuminations at a cost of up to approximately £600. Once identified, the Clerk is authorised to make the purchase.

104 Christmas Newsletter

The Clerk stated that he had sought three quotations for the Christmas Newsletter; however, only one was returned. The final price would depend on the number of pages within the newsletter.

Resolved that Low Cost Printing be awarded the contract to design and print the newsletter.

105 Remembrance Sunday

The Clerk stated that Remembrance Sunday is a day to commemorate the contribution of British and Commonwealth military and civilian servicemen and women in the two World Wars and later conflicts. Remembrance Sunday falls on 12 November 2023. Traditionally, the Council purchase a Poppy Wreath which the Chair of Council lays on behalf of the Community Council. The Clerk stated that a wreath had been ordered.

Resolved that the update be noted.

106 Street Naming & Numbering at Pentref Rhostir, Llangyfelach

Llanmoor Homes (<u>www.llanmoor.co.uk</u>) is the developer for the Pentref Rhostir, Llangyfelach development. The developer has asked the Council for suggestions for street naming. The developer states that from experience members of the Community often have far greater knowledge of the history of the area.

Resolved that any suggestions for street naming be forwarded to Councillor Mark Tribe, the Llangyfelach Ward Councillor on Swansea Council.



107 Swansea Community Review

The Clerk outlined the Swansea Community Review currently being undertaken by the Local Democracy & Boundary Commission for Wales. The Initial Consultation Period opened on 25 September 2023 and closes on 19 November 2023.
