**149 Workplan (For Information)**

**150 Swansea Council Matters: Planning, Highways, Footpaths, Cycleways & Bridleways**

**1) Parking of business vehicles on the footpath / highway on Swansea Road in the vicinity of the Plough & Harrow Public House**

Councillors considered the questions raised by the public earlier in the meeting. Their questions relating to the parking of business vehicles on the footpath / highway on Swansea Road in the vicinity of the Plough & Harrow Public House. The public expressed concern at the highway visibility issues that the parking was causing and also the impact on residents of the area.

Councillor Peter Gibson stated that he had raised concerns separately with Councillor Mark Tribe, Llangyfelach Ward Councillor on Swansea Council. The Clerk reminded Councillors that parking was an issue for Swansea Council.

Councillors instructed the Clerk to raise the following issues with Swansea Council:

- The danger caused by limited visibility for those vehicles needing to turn right when exiting the Plough & Harrow and / or neighbouring properties. What potential actions can Swansea Council do to alleviate this danger? Would a Traffic Restriction Order be appropriate?
- When the Community Council funded the Pelican Crossing on Swansea Road, a Bus Shelter was removed by Swansea Council. Councillors stated that they had received several requests for a Bus Shelter to be re-instated as it would be beneficial to residents of Llangyfelach during periods of inclement weather. As there is already a Bus Stop at this location and as it is close to the Pelican Crossing, is it possible for Swansea Council to re-instate the Bus Shelter at this location?

**Resolved** that:

- 1) The Clerk raises the above points with Swansea Council and feedback to a future meeting of Council.

**Note:**

- i) Councillor Mark Tribe stated that he would raise the issue directly with Swansea Council.
- ii) The public were informed that the issues raised were outside of the remit of the Community Council and were advised to raise their concerns directly with Swansea Council and with their local County Councillor.

### **151 Training Plan**

The Clerk stated that the Training Plan was adopted on 13 April 2023. It sets out the training requirements for Community Councillors and Staff. The monthly One Voice Wales, Planning Aid Wales and other relevant training schedules have been circulated. Councillors should regularly review their training requirements in line with the Training Plan & Training Matrix. To attend training, Councillors should liaise with the Clerk.

### **152 Llangyfelach Ward Councillor Update**

Councillor Mark Tribe, Llangyfelach Ward Councillor on Swansea Council gave a verbal report outlining his work within the Ward.

**153 Electricity Supply on Village Green**

The Chair stated that the Council had not received a bill for its electricity use for the Christmas Tree and Pea Lighting on the Village Green during his employment. He stated that he had established that SSE Energy Solutions was the energy provider for the Council's electricity meter on the Village Green. He stated that he had raised a query with SSE Energy Solutions and was awaiting a response.

**154 Appropriate Sum under Section 137(4) (A) of the Local Government Act 1972 - Section 137 Expenditure Limit for 2026-2027**

The Clerk stated that the Welsh Government had provided formal notification that the appropriate sum for the purposes of section 137(4) (a) of the Local Government Act 1972 (the 1972 Act) for Community and Town Councils in Wales is £11.60 per elector.

Section 137(1) of the 1972 Act permits each Community or Town Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Community and Town Councils are also permitted under section 137(3) to incur expenditure for certain charitable and other purposes.

For clarity, the Local Government and Elections (Wales) Act 2021 includes provision which enables 'eligible community councils' to exercise the General Power of Competence. The power for Community and Town Councils to exercise the General Power of Competence came into force on 5 May 2022.

**Resolved** that the update be noted.

**154 Society of Local Council Clerks (SLCC) - Principal Membership 2026**

The Clerk's Membership of the Society of Local Council Clerks (SLCC) lapsed on 31 December. The renewal membership letter has been received. Membership allows access to The Clerk magazine, conferences, courses, specialist advice notes, guidance notes and model documents. The cost being £218.

**Resolved** that the Clerks SLCC Principal Membership fee be paid by Council.
